With regard to all Cheques, Bills of Exchange and other instruments drawn or endorsed by me/us which I/we may lodge with you, or without other document, for collection, discount and/or purchase, the following instructions may be complied with :-

(1) The Cheque (s) Bill (s) and the relative documents may be sent by post or by other means at our entire risk and responsibility. An intimation by Ordinary Post or otherwise to the drawee of the receipt of the Bill (s) would be deemed sufficient presentment.

(2) If you have no office in the town in which any Cheque, Bill of Exchange or other instruments given to you for collection, discount and/or purchase is to be presented for payment or acceptance or for any purpose whatsoever, you will be at liberty to appoint an agent for presenting the bill for payment or acceptance and for delivering the accompanying document of title, if any, against payment or acceptance, as the case may be, and for doing all other acts, incidental thereto. The Agent so appointed will be deemed to have been appointed my/our agent.

(3) Neither you nor the agent will be responsible for any loss, delay or any mutilation or alteration of documents arising from, or occasioned by, their transmission by post.

(4) You and any agent appointed under (2) above will be at liberty to receive in payment of any Bill of Exchange, Cheque or other instrument lodged with you for collection, discount/purchase, a Cheque, Banker's Draft, Pay-Order, or other mandate for payment in lieu of cash and to deliver against receipt of such Cheque, Draft, Pay Order, etc. any Share Certificate, Bills of Lading, Railway Receipts or other documents that may be deliverable against payment of the Bills of Exchange, etc. and neither you nor the agent will be liable for dishonour of any Cheque, Draft, Pay-Order or other mandate so received and it is clearly understood that such instrument/s may be collected in any manner and by any agency at my/our entire risk and responsibility.

(5) Neither you nor any agent appointed under (2) above will be responsible for any loss or damage arising from the loss or miscarriage of any communications sent by post or by telegram or from any delay in their delivery or any error in telegram, unless such loss, miscarriage, delay or error is due to your negligence.

(6) In case the agent appointed under (2) above, to whom the Cheques, etc. may be sent for collection ceasing to function, suspending payment or going into liquidation or in the event of your not being able to realise proceeds of the Cheques/Bills tendered to you by such agent, due to any cause whatsoever, I/We myself/ourselves shall be responsible for the same.
